

2014 Transatlantic Entrepreneur Partnership Conference New York City, September 2-4, 2014

THIS YEAR'S TOPIC AND OBJECTIVE

This year's conference is dedicated to fostering a cooperation and dynamic between the cities of New York, Berlin, and beyond. These metropolises are already hubs of diversity, creativity, and innovation, and by learning from and cooperating with oneanother we can attract talents, risk-takers and investors, creating a network effect. This most likely applies even more to digital space than other areas of the economy. We want to examine how companies, startups, investors, policymakers, and the population at large can benefit from this synergy.

In addition, the three leading universities in Berlin have picked a group of 15 Berlin startups that are looking for US for market opportunities, US partners, and funding. These companies will pitch their ideas and get an introduction to what it takes to start your business in New York City.

THE PROGRAM

We start our conference in The OfficeLinks Hub, a modern co-working space, on September 2, the day after Labor Day, with a whole day of discussions around current developments in investments, media, the city, and policies. The German Consul General together with the American Council on Germany will host the group in the evening and have arranged for a fireside chat with German investors in the US. On Wednesday you will have the opportunity to discuss challenges and opportunities with a few New York experts and startups in their offices followed by a rooftop dinner on Fifth Avenue. The conference ends with a day all about starting in NYC - organized by the German American Chamber of Commerce - and the first NYC International Day with the Brooklyn Borough President. We are currently putting the final touches on the agenda. And yes, the Grand Havana Room will welcome us again for a drink.

THE FORMAT OF THE CONFERENCE DAY

Following a brief introduction of the topic and each speaker, we ask panelists to present their perspective for 3-5 minutes. They will include their background, and focus on concrete examples and activities, list resources, and especially focus on looking forward to 2015 and beyond. As always, please be forward looking and provide examples and resources. Following the presentations, there will be a panel discussion, moderated by one chairman/chairwoman.
